Overview

Flexspace Middlesbrough is a substantial business centre providing a range of furnished offices, warehouses, workshops and self-storage units that are available on flexible terms.

The centre is telecoms & IT enabled and provides free car parking and CCTV security.

The 42 offices range from 110 to 385 ft² (33 to 117 m²), including a range of executive office suites. The offices can be let with or without furniture.

Self-storage units range from 25 to 130 ft² (2 to 12 m²) and are available for commercial and domestic use.
